The meeting of District Development Committee (DDC) was held on 11/02/2022 at 12:30 PM in the Conference Hall of Deputy Commissioner office, Morigaon. The meeting was Chaired by District Development Commissioner, Morigaon. At the onset the District Development Commissioner, Morigaon, welcomed all the members present in the meeting.

Previous minutes of DDC meeting was reviewed and the following decisions were taken in the meeting: -

Sectors	Issues Discussed & Decisions Taken	Action to be taken up, if any
PWD Territorial Roads	The Executive Engineer, PWD, Regional Road Division, Morigaon, informed that the hurdles in Tengauri bridge has been resolved and work has been completed. He also assured that the work of Basanaghat to Bhuragaon road would be completed within 15 days.	E.E, PWD Territorial Roads
Irrigation	The Executive Engineer informed that all the ongoing schemes will be completed within March, 2022. The Solar scheme is 100% completed but in electrical, 291 schemes have been completed and 99 schemes are yet to be completed. He also informed that, low voltage problems will be resolved soon, as discussed with APDCL. In this regard, DC also asked the EE to expedite the work and shift from electric to solar. PHE	The Executive Engineer, PHE, Morigaon informed that out of 7 schemes 6 numbers have been initiated under JJM. 114 private land issues have been resolved and agreement has been done with the stakeholders. Draft DPR of schemes have been processed and few of them have been sent to the Govt. for approval. DC asked the EE and Contractor of Moirabari division (Dhing part) about the sluggish progress and poor achievement of FHTC targets. He also asked the Officers to expedite the work and achieve 1000 targets within this month and submit the progress reports of all schemes with photographs to Deputy Commissioner periodically. EE also assured to achieve the targets and informed about the problem occurred in uploading	EE, PHE, Morigaon


	356 FHTC schemes in the portal in respect of Moirabari division. Water facility in schools/Anganwadi centers under JJM's 100 day campaign, 155 schemes in schools and 109 schemes in Anganwadi centers in January, 2022 have been completed.	
Agriculture	The Executive Engineer, Agriculture, Morigaon informed that only 79 beneficiaries data have been uploaded on the portal out of 5839 new eligible beneficiaries. DC asked the EE to collect new applications of PMKISAN from the Circle Offices.	DAO, Morigaon
DIC	The General Manager (GM), DICC informed that, meeting regarding PMEGP held with all the bank managers and they assured to give sanctions of proposals by February-March, 2022. The GM, DICC also stated that, 9 sanctions intimidated by PNB, Moirabari, is yet to be uploaded in the PMEGP portal. In this regard, DDC has asked the GM, DICC to send officers to banks to expedite the process.	G.M, DIC, Morigaon
APDCL	The CEO, APDCL informed that under DDUGY, targets have been achieved. In Anganwadi Center and Primary School in Morigaon Electricity Circle, 721 out of 1757 and 18 out of 577 targets have been achieved respectively. Inspector of Schools also asked the CEO to complete the electrification of School before the start of Gunotsav. In this regard CEO asked the IS to submit the survey reports of school/center to APDCL to expedite the process. CEO also informed that the shifting of electric post in Bakharbari village is completed. DDC also asked the CEO to look into the matter related to temporary connection at Dalbari under Governors composite centre.	CEO, APDCL/ IS, Morigaon
Health/NHM	The Joint Director Health Services informed that 100% of first doses have been administered in Morigaon district but 2 <sup>nd</sup> dose is not completed due to migration of people to other states and reluctant nature of people. For the age group of 15 to 18 years, 90% of the total beneficiaries are vaccinated with the first doses. The Joint Director of Health Service also informed that Mission INDRADHANUSH is successful in Morigaon district and also reported that MMR rate is less than the state average. Education	The Inspector of Schools informed about the shortage of External Evaluators for the GUNOTSAV, 2022.	DEEO & IS, Morigaon

Fishery	The District Fishery Development Officer informed that total 155 applications have been received for village community tanks under CMSGUY scheme. Overall 77% progress is achieved and 630 numbers of beneficiaries are covered under Pradhan Mantri Matsya Sampada Yojana (PMMSY). DFDO also informed about the weekly campaign of Fishery KCC and spot registration of the eligible beneficiaries.	DFDO, Morigaon
Sericulture	The Assistant Director Sericulture informed that, two Cluster Approach as a Governors adopted districts are to be set up in Nellie and Bhurbandha.	ADS, Morigaon
Forest	The Forest official informed that, illegal mining has been dismantled and fine imposed on violators. The Officer, also informed that, forest royalty in Morigaon district has been increased. DDC asked to submit the monthly departmental report of forest to Deputy Commissioner regularly. DDC also asked to implement plantation scheme in Charan Beel. In this regard, a joint survey may be conducted by Social Forestry division, KVK and ADC.	DFO, Nagaon Division/KVK/A DC
Water Resources	The Executive Engineer, Water Resource Divn., Morigaon informed that 3 projects under NABARD/RIDF is increased from 65% to 80% and is expected to be completed by February, 2022. He also reported 5% progress of the construction of Sluice Gate at Matiparbat of Killing-Kopili junction under SOPD-G scheme. Under SDRF scheme, immediate measures of recoupment of B/Dyke from Dhing to Hiloikhunda is 100% completed.	EE, Water Resource, Morigaon
Labour	Labour Officer informed that registration of unorganized workers under E-Shram portal is going on and targets will be achieved shortly. DDC asked the Labour Officer to collaborate with Zila Parshad for registering job card holders and workers from other line departments under this scheme. Labour Officer has also raised an issue regarding not issuing required certificates by Principal of educational institutions for providing Scholarship to eligible beneficiaries. In this regard, DDC asked the IS, ADC (Education) and Labour Officer to resolve the matter jointly.	Labour Officer, Morigaon/IS, Morigaon/ ADC (Education)
ITI	Principal ITI, Dandua informed that fitting and fixing of partition in newly constructed ACR at ITI Dandua is yet not started. He also requested to provide two speed breakers on the approach	Principal, ITI, Dandua/ EE, PWD (Roads)

	road of ITI, Dandua & asked the EE, PWD (Roads) to construct the same.	
PWD (Building)	Junior Engineer, PWD (Building) informed that, work of civil hospital is 10% completed. He also informed about the documentation process of LMO tank and progress of RTPCR lab. He also answered a query raised by the Dist. Animal Husbandry and Veterinary Officer, regarding cancellation of Shantipur Veterinary Dispensary building under RIDF scheme.	€EE, PWD (Building), Morigaon
Social Welfare	District Social Welfare Officer informed that, Geo Tagging of AWC is 80% completed and will be fully completed within 2 to 3 days. In this regard, DDC asked the Officer to send the Geo Tagging data of AWC to Decentralized Planning Branch, Morigaon, to boost the effective implementation of AAGY/PMAGY schemes. DDC also asked the DSWO , Joint Director of Health and ADC, Health to fix the date of disability camp immediately after the DDC meeting.	DSWO, Morigaon/JD, Health/ ADC, Health
Veterinary	Dist. Animal Husbandry and Veterinary Officer informed that 10 female goats and 1 male goats have been provided to each of the 90 SHGs.	DAH&V, Morigaon
PWD (NH)	EE, PWD, NH informed that the Kapili Bridge proposal is already submitted to the Govt. and sanction is yet to be received. Land acquisition of Basanaghat-Bhuragaon road is going on.	EE, PWD (NH), Morigaon
